European recognized guideline for good governance and excellence in public sector

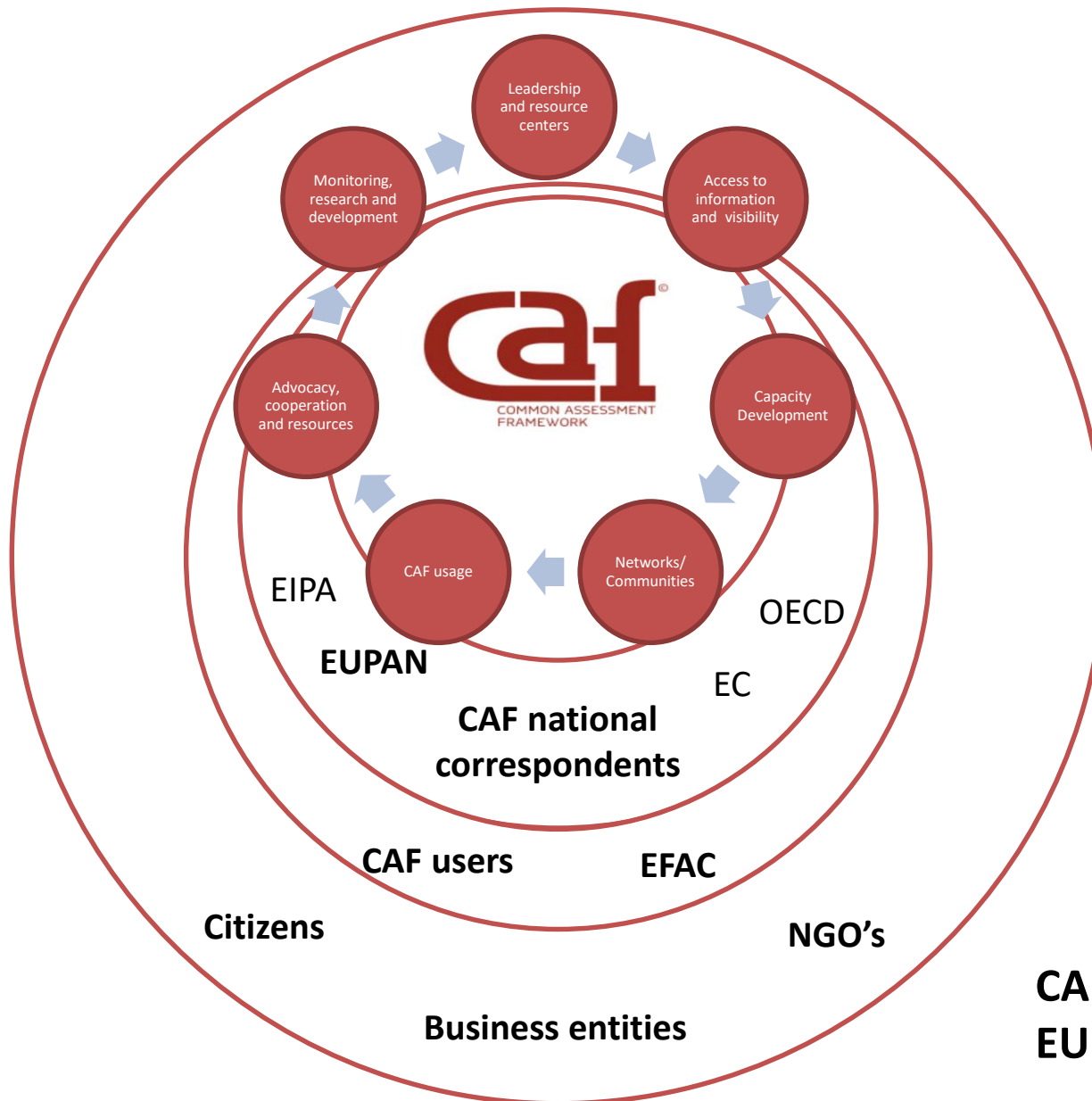

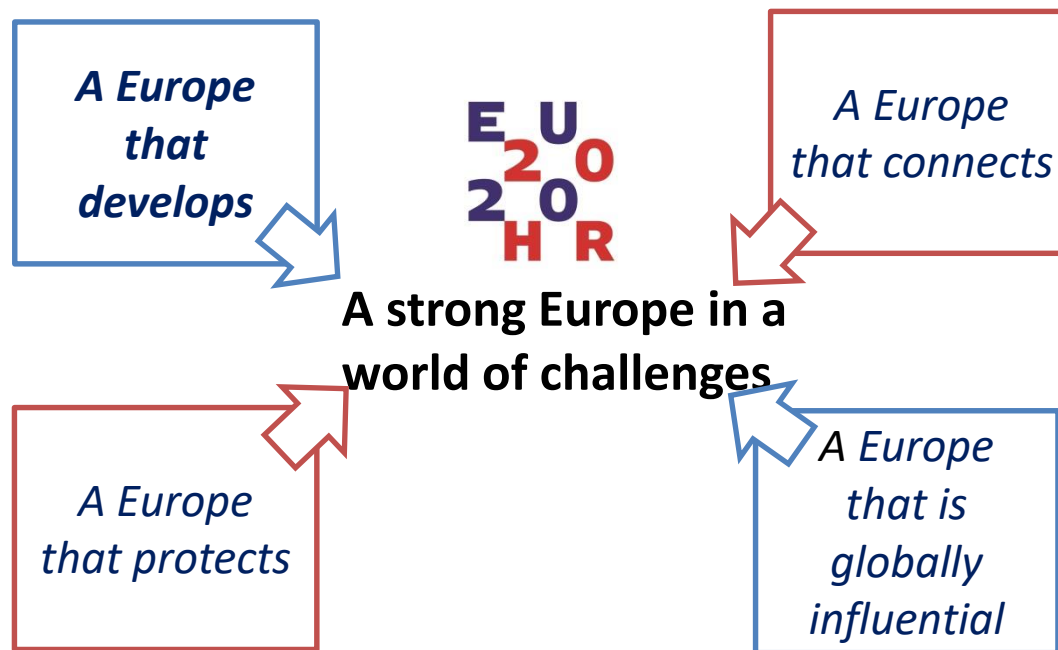

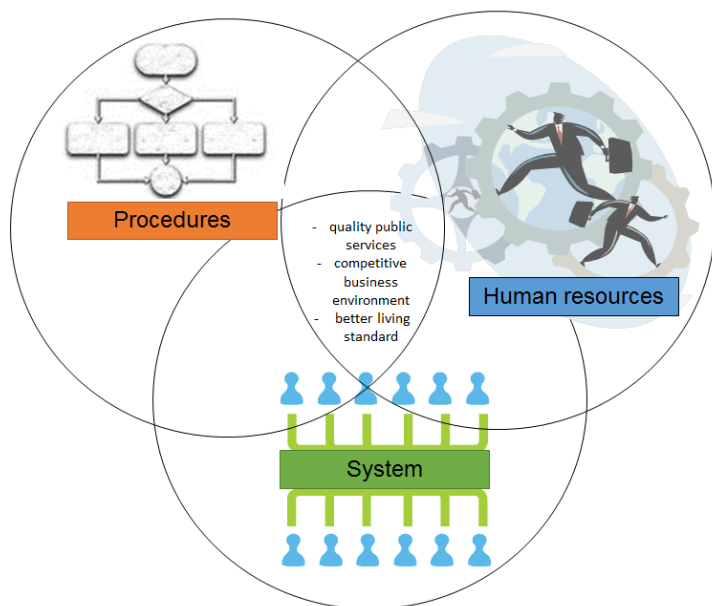
