Training Needs Analysis

Conducted beginning of 2024 – targeted CAF users, national correspondents, EFAs, and CAF experts.

High demand for

- Self-assessment process (CAF Phases at a Glance)
- Soft skills and facilitation techniques
- External Feedback Procedure training

Pilot Event

Held at EIPA Maastricht in November 2024.

30 participants from 13 countries + ReSPA and GIZ representatives.

Positive feedback → curriculum refined based on input, and published for free use on EIPA`s website.

Intergenerational and multicultural learning in the CAF community: senior knowledge, sharing the perspectives with the new generations.

Recommendations

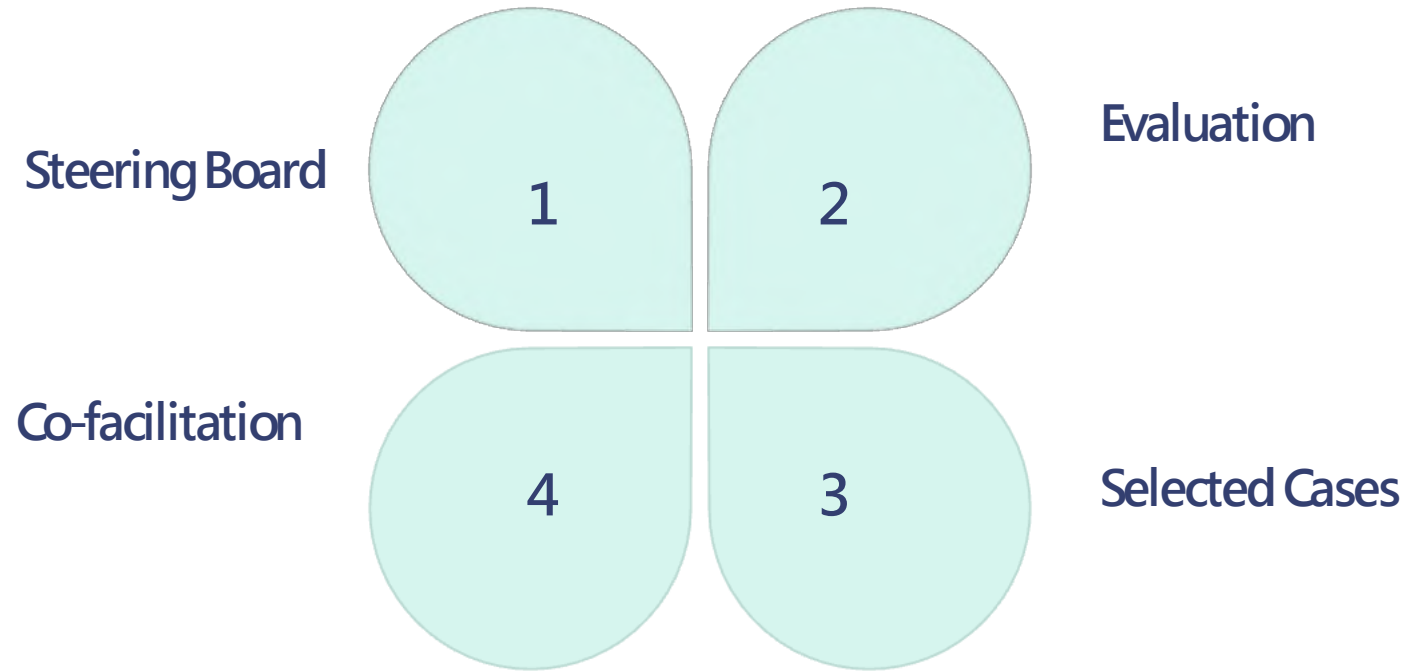

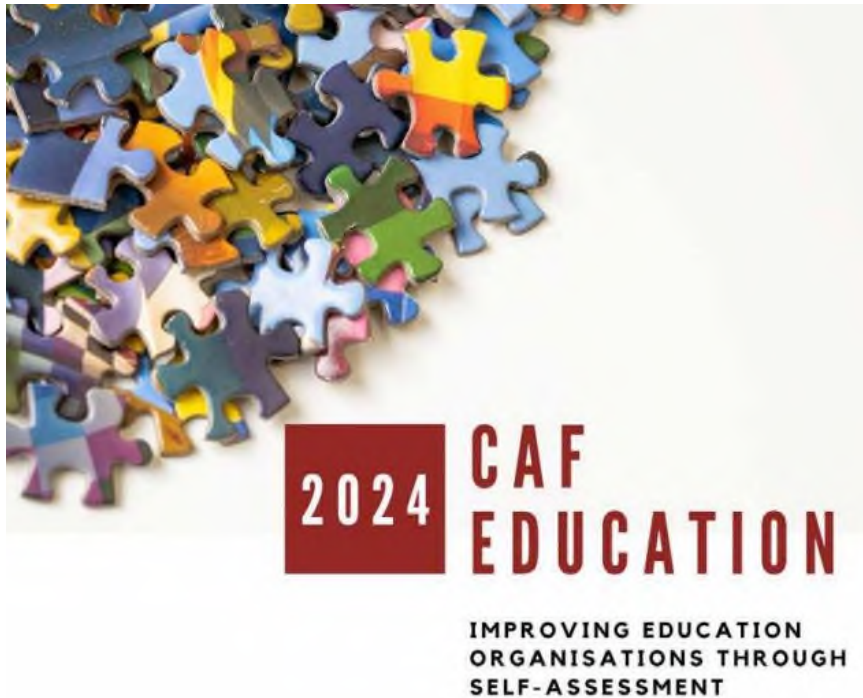
